| <u>Mike</u> Dworetsky | Mike first became interested in the JFK case when he attended a lecture by Mark Lane at UCLA in 1966, in which he outlined the content in "Rush to Judgement". At the time he was a PhD student in Astronomy. |

| | His interest was revived when as an astronomer at UCL he read Anthony Summers' "Conspiracy" in 1980, based in part on the HSCA report. He examined closely the report and testimony about the gunshots and concluded that there was more to be learned, and that there was clear confusion about exactly what the scientists had found. |
| | The Warren Commission had taken a lot of verbal testimony about gunshot timings but paid little attention to it, in order to support their single-bullet theory. In fact, the sound recordings and testimony could be reconciled, provided one allowed for the fact that witnesses overestimate the amount of time between events. He presented these results at two DPUK meetings. |
| | He is now retired and hopes to be able to devote more time to writing up the details for the Echo. DPUK members will also remember him as their friendly auctioneer. He is also interested in the peculiar life of Lee Oswald and is certain that he was not a lone- nut assassin, and probably not an assassin of any sort. |
| <u>Johnny</u> <u>Cairns</u> | Johnny lives in Edinburgh, Scotland. His father, Robert Cairns, got him interested in the life and death of JFK. |
| | With respect to the JFKA, Johnny has focused on the flawed and circumstantial evidence against Lee Harvey Oswald. |
| | He has presented at JFKA conferences, written articles that have been published on- line and co-authored "JFK Case Not Closed" which was published in 2022. |
| Paul Jeffery | Paul first became fascinated with the JFK assassination case after watching the Oliver Stone movie in the 1990s. |
| | Over the past 30 years his main areas of interest have been the people potentially involved in the plot and cover-up and subsequently the possible links into other so-called conspiracy cases, stretching from the RFK assassination into the 21st century. He believes these connections are why the question of 'who shot JFK?' is still vitally relevant today. |
| | A previous speaker and writer for DPUK, Paul also runs a Facebook group dedicated to the disappearance of York resident Claudia Lawrence. |

| <u>Paul Brown</u> | Paul has been interested in the assassination since his youth when he was introduced to the subject during the 30th anniversary. |
| | He has a degree in politics from The Open University and works in local government. |
| | As a member of DPUK since 2008 he has given presentations at Canterbury on various issues including the deaths of witnesses, the Dal-Tex building and the audio/visual evidence. He believes there was a conspiracy that most likely involved the same people linked to the CIA/Mafia plots against Fidel Castro. |
| Pete Mellor | Pete lives high on Saddleworth Moor & has studied the JFK assassination around thirty years. |
| | He has attended conferences in Dallas 2003 & 2013, also presenting in 2020. He has contributed to books published on the assassination & has presented at DPUK seminars, as well as writing articles for the DPUK journal 'The Dealey Plaza Echo'. |
| | He has just recently given a lecture on the JFKA to over two hundred attendees at a local 'University of the Third Age' event and consequently is now listed on the U3A national register of speakers. |
| | At the York seminar he will present a study of the CIA's Counter Intelligence Chief James Jesus Angleton. |
| David Percox | David had a passing interest in the JFK assassination as schoolboy when he learned that it had occurred the day before his parents' wedding and it further developed when he studied history and politics at Keele University. |
| | It was whilst teaching at one of his first schools, that he was pleasantly surprised that the Kennedy assassination was being taught in the UK as part of the National Curriculum and that pupils were discouraged from accepting the Warren Report! So, whenever he could, he taught the assassination to willing and engaged school students. |
| | He finally visited Dallas in 2015 and has contributed to DPUK as a presenter at the 2018 conference on the shooters in Dealey Plaza and as an author of a DPUK Echo article about Kennedy's and Connally's wounds. |
| | More recently, David has been collaborating with Greg Parker of ROKC with respect to researching and analysing Oswald's alleged southbound journey to Mexico. |
